The Company features an international roster of award-winning dancers. Elegant and exciting, they are at the heart of the company's undeniable success.

Dance Alive's repertoire ranges from the classic *Nutcracker* to the cutting edge of contemporary ballet. Throughout this choreographic tapestry are woven the ballets of Company Founders Artistic Director Kim Tuttle and Company Choreographer Judy Skinner whose distinctive artistic styles brand the company.

Entertaining and insightful, provocative and joyous, this creative aesthetic is at the heart of the Company.

The Company has a home performance season at the Curtis M. Phillips Center for the Performing Arts in Gainesville, Florida. Additionally, DANB partners with the Reilly Arts Center in Ocala, and the City of Alachua. Alachua's Legacy Park Multipurpose Center hosts its signature fund-raising event, the "Champagne Gala" featuring the hugely successful Gainesville's own "Dancing With the Stars" competition.

- Ever enrich the creative spirit of the dance artist.

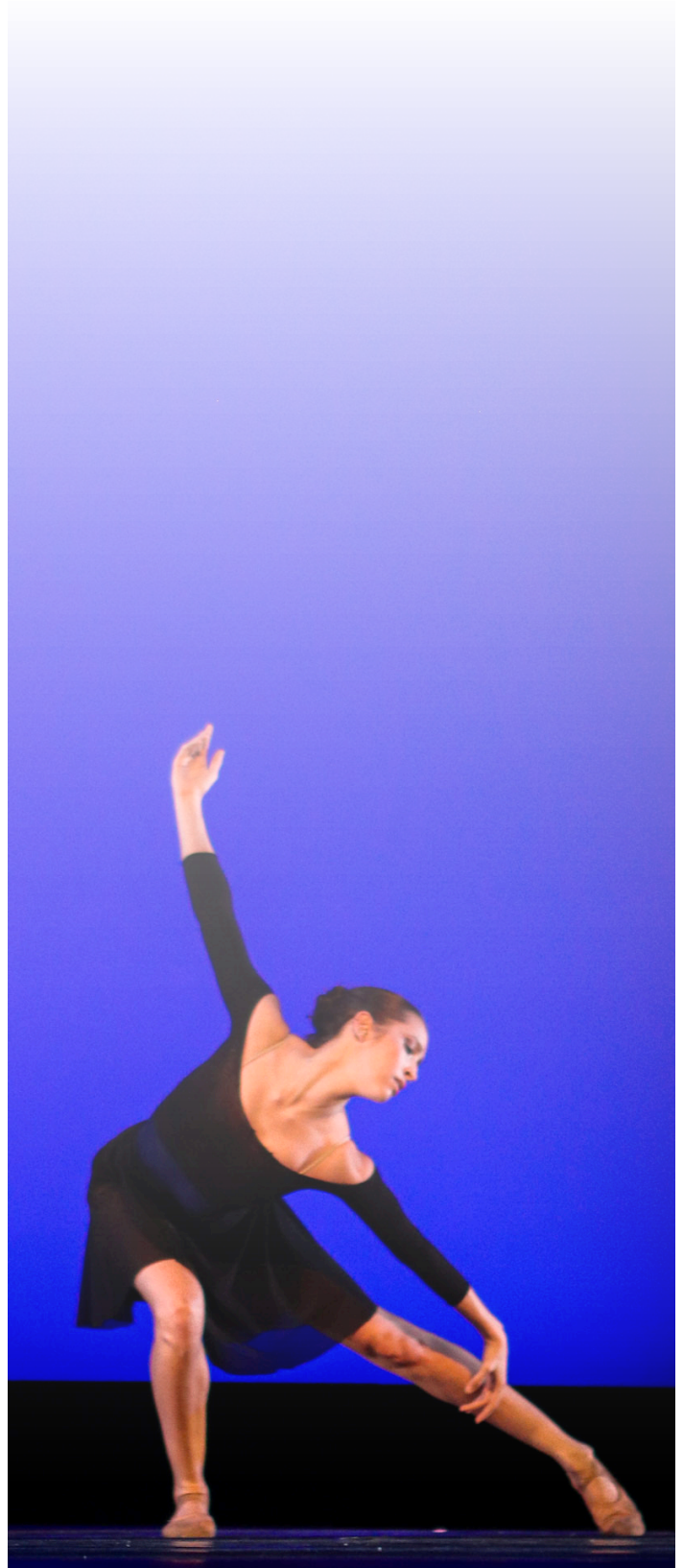

OUTREACH PROGRAMMING

DANCEABOUT

Dance Alive National Ballet's Educational Outreach Program brings dance to the community through experience and education in a fun and uplifting way, providing dance instruction in selected venues.

DISCOVERING DANCE

Students from Alachua and surrounding counties are brought to selected daytime professional mainstage productions in the setting of the Phillips Center and selected theatres. Students from public, private, charter and home schools are provided access while parents and educators are provided multi-disciplinary, grade-specific curriculum guides available online and in hard copy, keyed to Florida literacy standards.

DANCE PARTNERS

Dance Partners brings live professional dance at no cost to clients of social service and non-profit agencies in the City of Gainesville and Alachua County.

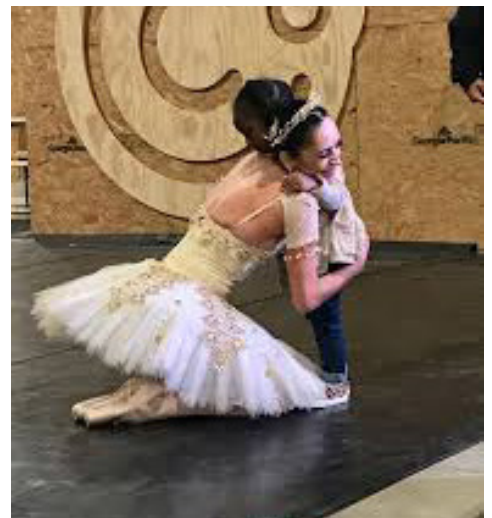

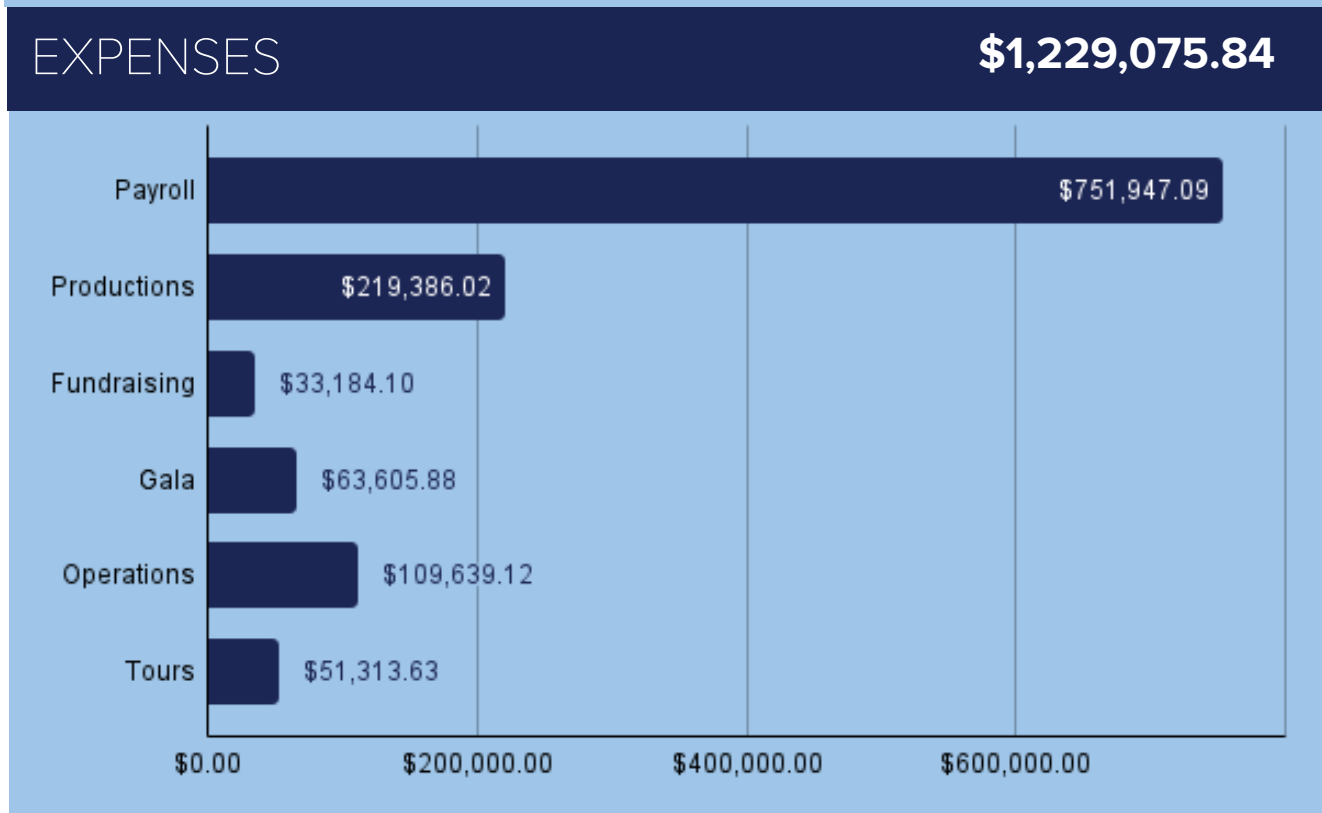
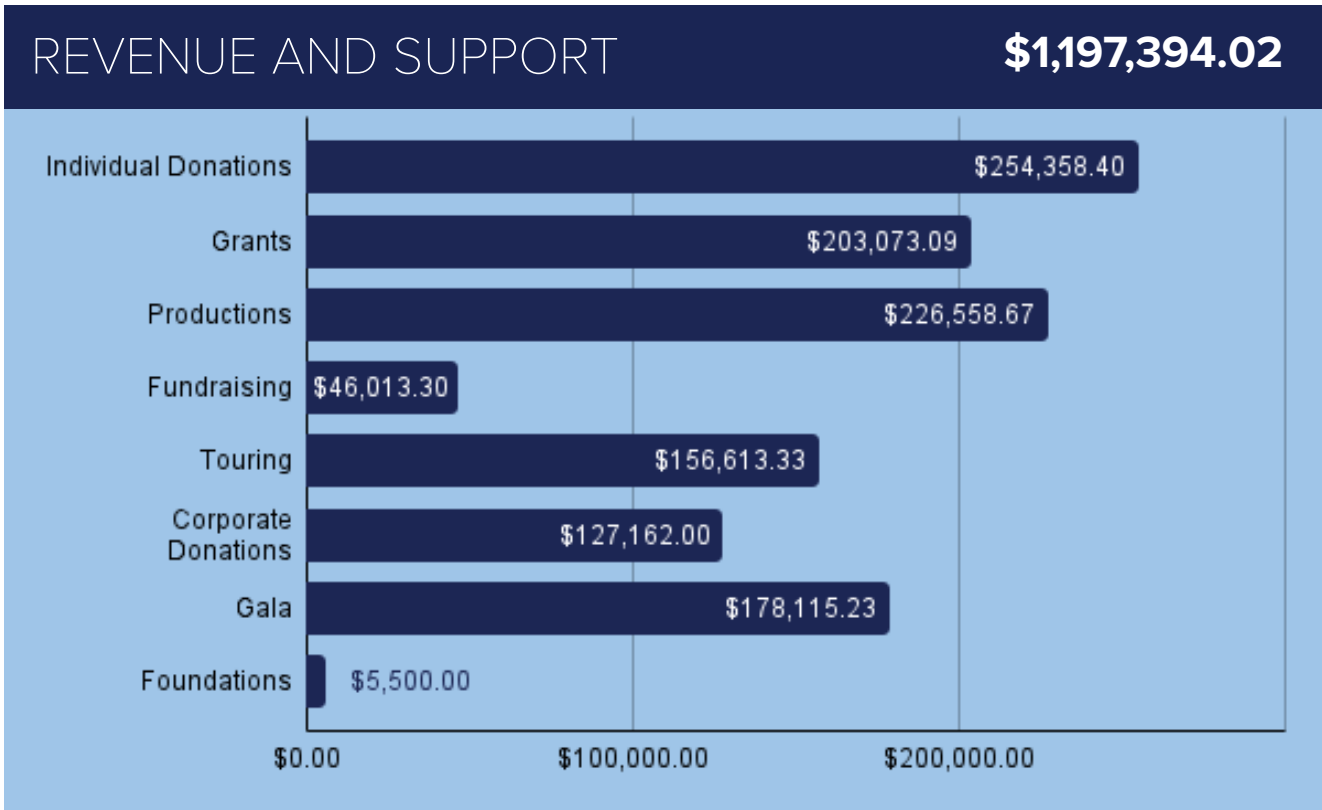

STATE OF THE COMPANY

In 2020 DANB made the monumental decision to purchase property upon which to build a new Dance Alive National Ballet Center for the Arts. The property, located at the corner of NW 39th Avenue and 34th Street in Gainesville, was officially purchased on Friday, June 28, 2024. The process was long.

It is a testament to the superb artistic and business efforts of the Pofahl family, parents Kimbel and Mary Ellen and daughters Judy Pofahl Skinner and Kim Pofahl Tuttle, and the diligence and support of decades of superb board members and staff that this had been accomplished.

In the 2024-25 season, Dance Alive increased attendances at all home productions, touring programs, and fundraisers. The programming included the popular SWAN LAKE, with DANB principals Carla Amancio and Tales Ribeiro, the all-time favorite NUTCRACKER with public performances and school shows, our Valentine's Day special DANGEROUS LIAISONS, and the stunningly beautiful ROMEO and JULIET with DANB Company Principals Rosemary Deiorio and Tales Ribeiro. It was a spectacular close to the performance season.

Outreach programming increased with the after-school program DANCEABOUT led by Outreach Director Emily Pozek Dixon. DANCEABOUT is a program designed to give free dance classes to elementary school students. The program was presented in Alachua, Florida for the fourth year, and a program of DANCEABOUT in Ocala, Florida continued for the third year. The partnership with the City of Alachua expanded to include a public NUTCRACKER performance and the CHAMPAGNE GALA annual fundraiser, with the hugely popular local "Dancing With the Stars" as the centerpiece. The partnership with the City of Ocala and the Reilly Arts Center continued with three performances of the NUTCRACKER to sold out audiences, as well as a sold out school show and a performance of LOVELAND.

A very important OUTREACH development was the partnership with The Children's Trust of Alachua County and the City of Gainesville in a program for children with special needs, called 'LET'S DANCE'. This pilot program was extraordinarily successful and will be repeated through the 25-26 season.

Regarding the fiscal health of the Company, for the third year in a row, the budget exceeded \$1 million, and continues to grow. This was due to the continued excellence of the productions, but also to the excitement generated by a new home for the Company. To date, \$4 million has been raised toward the property purchase and building, in part due to a \$1 million donation from the Khoury Family Foundation, three generous donations of \$500,000 each,

a Cultural Facilities Grant from Alachua County for \$500,000, several \$100,000 donations and individual smaller donations along with a complete board participation. In addition, Nancy Turano, formerly Artistic Director of New Jersey Dance Theater, donated the entire interior of her dance studios to DANB. That includes all sprung floors, barres, sound systems and monitors, costumes, board table and chairs, and much more. Genesis Door Inc. has donated all doors, both interior and exterior, and will provide a resource for other capital goods, and Project Manager and Interior Designer Arzu Erenguc (and former student of Pofahl Studios) is donating all of her time and expertise to the project. The Capital Campaign is led by Board of Trustees Capital Campaign Chair, James Roberts. Architect James Blythe of BXP Architects has worked with Kim Tuttle on creating a streamlined, efficient and beautiful space, and at this time, Scherer Construction is doing the build, and ground breaking will be August, 2025.

The new Khoury Family Center for the Arts will be 22,000 square feet, and will include three dance studios, three music studios, a black box studio theatre, an

art gallery and accompanying administrative and storage spaces. It is a true Center for the Arts for the City of Gainesville and north central Florida. The estimated opening date is August 2026.

Currently, the property owners/directors of Pofahl Studios, Kim Tuttle and Judy Skinner, allow DANB to use their studio space free of charge. However, when the new DANB Center for the Arts officially opens, Pofahl Studios will merge with DANB to become one non-profit entity, the Dance Alive National Ballet Center for the Arts, with a dance division, music division, and rental facilities.

Dance Alive welcomed new Executive Director Timothy Cannon, recently retired as President and CEO of Alliance Credit Union and former Vice President of the Board of Trustees of Dance Alive as well as former professional dancer, Public Relations Director, Susan Scannella, and new Marketing Manager, Darcy Herlihy. The Company said goodbye to Grants writer and Administrator Brenda Swann and welcomed new Grants Writer and Manager, Ronda Bourn in August 2024. Ms. Scannella received her early dance training from Pofahl Studios, as did Ms. Bourn. It is a testament to Pofahl Studios that individuals of their caliber return to invest their knowledge and talent in the organization.

Besides the addition and expansion of the administrative side of the organization, the artistic side has continued to grow and thrive as well. Newly-promoted Principal Dancer, Tales Ribeiro, continues to become a well respected choreographer in residence for the Company, Ribeiro and Company Principal Rachel Ridley took over the Directorship of the Next Generation, a school-driven company of aspiring students who perform at retirement communities and arts festivals, as well as present their own concerts. Guest artists Sterling Baca and Oksana Maslova, Principals with Philadelphia Ballet, continue to participate in programming, bringing their superb talent when called upon.

The development of dancers within the Company continues to grow, and the Company is fortunate to have dancers in the Company who were trained at the resident school, Pofahl Studios, as well as dancers from all over the world, combining to make a diverse and richly artistic group. It shows that the level instruction at Pofahl Studios is of a professional caliber, and this effort will continue to grow at the new Center for the Arts. The Company has toured 17 states, Costa Rica, Cuba, Brazil, Bulgaria, Russia and virtually in Japan, and is comprised of an international roster of stars.

The new Center will attract new students and new donors, and offer a rental space for the entire community.

The strongest advocate for the Company is the President of the Board of Trustees, Lorie Gleim, also a former student. Her guidance has been invaluable, and the Board of Trustees has prospered under her Presidency.

The State of the Company is in a superior position, artistically, administratively and fiscally.

The future looks promising indeed...

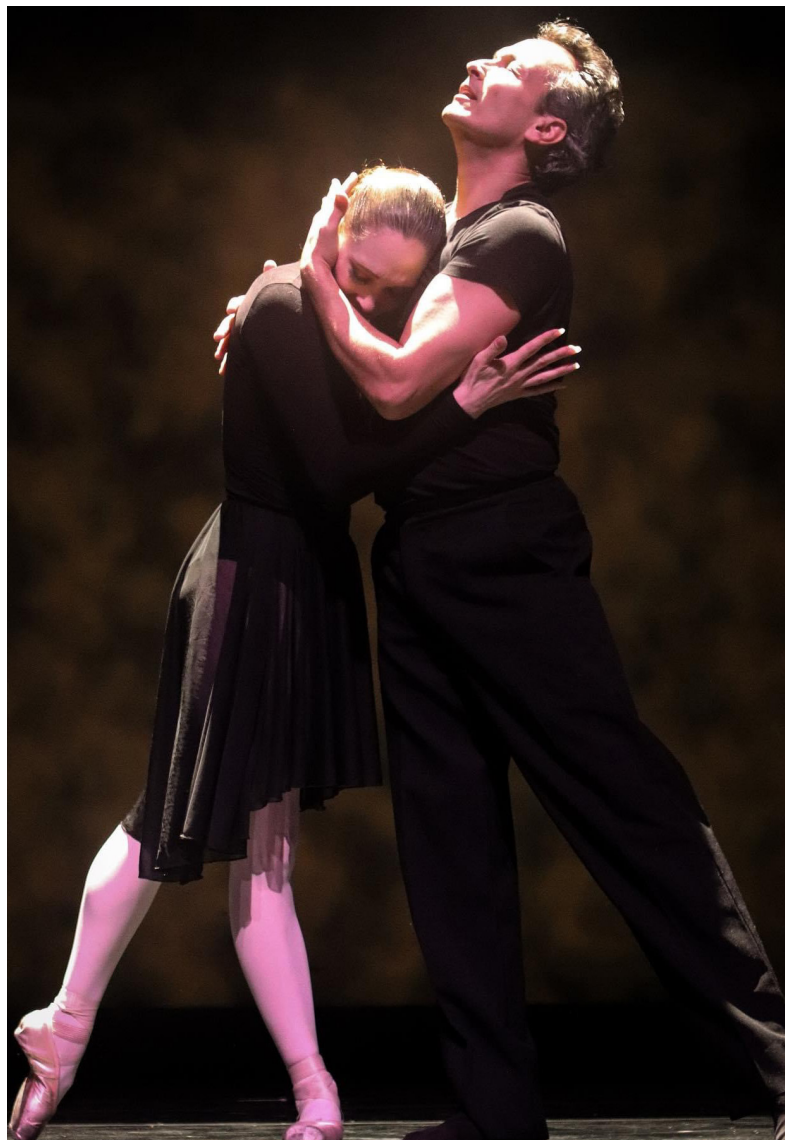

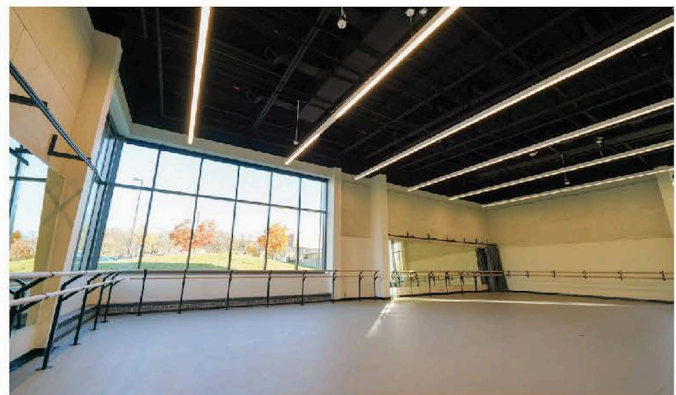

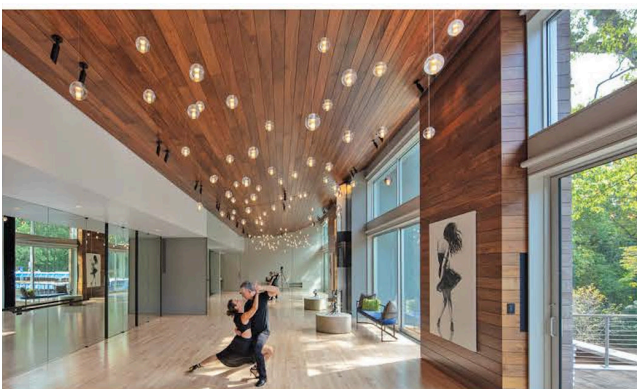
